

AUTHOR BIOGRAPHIES

Susan Blackman is a full-time Research Associate at the Canadian Institute of Resources Law. She has a B.Sc. in biology, and both LL.B. and LL.M. degrees. She is Service Editor for the *Canada Energy Law Service — Federal* and the Canadian oil and gas and mining law reporter for the *Rocky Mountain Mineral Law Foundation Newsletter*. Her research has included studies on natural resource management in a federal framework, environmental law, oil and gas regulation, and intergovernmental agreements.

Eugene E. Dais is a Professor of Law at the University of Calgary where he has taught since 1976. Previously, he taught constitutional law and jurisprudence in the Political Science Departments of the Johns Hopkins University and the University of Calgary and from 1970 to 1974 chaired the committee on establishing the Law Faculty. He holds the A.B. degree from the University of California at Berkeley, and the J.D. degree from Harvard Law School. Professor Dais teaches constitutional law, jurisprudence, land use planning and trusts. His publications, mainly in jurisprudence, include editorship of *Law and the Ecological Challenge* and co-editorship of *Constitutionalism versus Legalism*. He recently chaired the Appointments, Promotion and Dismissal Committee of General Faculties Council of the University of Calgary that reviewed the dismissal procedures and provisions for academic freedom. He also has served as a member of the Board of Directors of the Law Reform Institute of Alberta, and continues to serve as Chair of the Board of Examinations in Law of the Alberta University Co-ordinating Council.

Richard Devlin obtained his LL.B. from Queen's University, Belfast and his LL.M. from Queen's University, Kingston. Formerly an Associate Professor of Law at the University of Calgary, he was appointed in 1993 to the Faculty of Law of Dalhousie University. His teaching interests include legal theory, graduate level studies, contract law, business associations and, when coerced, commercial law. Professor Devlin has published widely in Canadian, American and British journals. He is the editor of *Canadian Perspectives on Legal Theory* (1991). His present enterprise is a lengthy monograph tentatively entitled: *Postmodern Republicanism*, which he hopes will mature into his first book.

Janet Keeping is a Research Associate with the Canadian Institute of Resources Law. Her research interests centre on energy issues, especially the regulation of energy utilities, the relationship between environmental protection and energy development and the energy aspects of modern land claims agreements.

Sheilah Martin was appointed Dean of the Faculty of Law at the University of Calgary effective July 1, 1992 after a six-month appointment as Acting Dean. She came to the Law School in 1982 and was recently promoted to the rank of full professor. She obtained a B.C.L. and LL.B. degree from McGill University in 1981. She studied oil and gas law at the University of Alberta and obtained her LL.M. in 1983. Recently Dr. Martin completed an S.J.D. degree from the University of Toronto; her thesis was on legal controls on human reproduction and the implications of the *Canadian Charter of Rights*

and Freedoms. Dr. Martin has taught in many different areas including feminist legal theory, torts and loss compensation and commercial law. She has written widely in the areas of constitutional law, feminist jurisprudence, legal controls on human reproduction, health care, and law and medicine. She co-edited the work *Equality and Judicial Neutrality* and has participated in judicial education seminars on the issue of gender bias.

John McLaren is currently Lansdowne Professor of Law at the University of Victoria and formerly Dean of Law at the University of Calgary. His teaching and research interests include Canadian and English legal history. He has written on the history of environmental regulation, the law relating to prostitution and pornography, and institutionalized discrimination. His present projects include work on a book on *White Slavery Scares and Prostitution in Canada, 1880-1920*, and research into the use of state power and law against the Doukhobors in the 1930s and 1950s.

Nicholas Rafferty is currently a Professor of Law at the University of Calgary where he has taught since 1977. Before that time, he taught for two years at the Faculty of Law, the University of Manitoba, and was a teaching fellow for a year at the College of Law, University of Illinois. He obtained both his law degree and a master's degree in law at Jesus College, University of Cambridge and a further master's degree from the University of Illinois. His teaching interests include contracts, torts and conflict of laws. His research has focused on the private law of obligations, especially contracts, torts and restitution, some commercial law and conflict of laws.

Monique Ross joined the Canadian Institute of Resources law as a Research Associate in September 1989. She obtained her B.C.L. from the University of Toulouse, France, an LL.M. from the University of Montreal and a master's in urban and regional planning from the University of Calgary. Ms. Ross' past research has focused on environmental law and forestry law. She has completed a study on the implications of environmental protection legislation on the forest sector, and is at present the principal researcher for a two-year research project on Canadian forest management.

Patricia Rowbotham is an Assistant Professor in the Faculty of Law at the University of Calgary. She has taught in the areas of natural resources law, energy law, civil procedure and evidence, wills, torts and trial advocacy. She has been an active member of the Law Society of Alberta since 1983. Prior to joining the Faculty of Law in 1990, Professor Rowbotham practised primarily in the area of civil litigation with experience in insurance, commercial, employment, oil and gas and environmental litigation.

J. Owen Saunders is Executive Director of the Canadian Institute of Resources Law and Adjunct Professor in the Faculty of Law at the University of Calgary, where he teaches public international law. Professor Saunders studied economics at St. Francis Xavier University and Queen's University, and holds law degrees from Dalhousie University and the University of London (London School of Economics and Political Science). His research interests have included international environmental law, trade law and constitutional law. He has written numerous articles on the legal aspects of natural resources management, and has acted as an advisor to federal, provincial and foreign governments on resource management environmental issues. His recent research has

included work on the implications of North American free trade for natural resource industries, on sustainable development and on the implications of environmental law on the forest sector.

M. Anne Stalker is an Associate Professor at the University of Calgary. She teaches in the areas of criminal law, criminal procedure and evidence, and legislation, and her research interests reflect those teaching interests. Professor Stalker has also been heavily involved in policy-oriented administration, where she tries to make use of some of her work in criminal law, process and legislation: at the University of Calgary, she is the current Chair of the President's Committee on Sexual Harassment and serves on the Ad Hoc Committee on Professional Ethics for Academic Staff and on the Appointment, Promotion and Dismissal Committee (a policy committee). She has in the past been an active consultant with the Law Reform Commission of Canada and in the past year has been involved in the Department of Justice's efforts to replace the work of that Commission. Finally, she is the current President of the Canadian Association of Law Teachers and Chair of its Criminal Law Section.

Michael Wylie is Associate Professor of Law at the University of Calgary. He obtained an LL.B. from Dalhousie University and a B.C.L. from Oxford University. He is a member of the Law Society of Alberta and conducted a general practice of law prior to joining the Law Faculty. His teaching and research interests lie in the areas of business law, law and society, and legal skills.
